

MELANIE JAMESON: PROFESSIONAL ACTIVITIES

Initial Qualifications and Work pre-2000

- BA in Modern Languages (French, German and Russian), Bristol 1975.
- Prison education tutor (HMP Highpoint, HMP Horfield, Lancaster Farms YOI).
- RSA Diploma in Specific Learning Difficulties 1991.
- Associate Member of the British Dyslexia Association 1996.
- Numerous assessments of SpLD children, FE and HE students and adults (both privately and clients of the Employment Service). CPD for teachers accredited by Lancaster University.
- Consultancy (usually comprising training, development of materials, advice on disability policy) for: Home Office, Prison Education Services in Northern Ireland and Scotland, Law Society, College of Law, RAF Cosford, Trade Unions and various Probation Services.
- Dyslexia assessments at YOI Lancaster Farms resulted in the creation of an offenders checklist for Dyslexia and Visual Stress; this has since been widely distributed and 'written into' documentation produced by the Northern Ireland and Scottish Prison Education Services.

Work undertaken from 2000 relating to Offenders / the Justice System

- By 2000 all work incorporated the family of Specific Learning Difficulties (Dyslexia, Dyscalculia, Dyspraxia, Attention Deficit (Hyperactivity) Disorder and Asperger Syndrome).
- Expert witness work was undertaken with submissions and court appearances on behalf of adults with Specific Learning Difficulties.
- A number of briefings were provided on criminal justice issues for House of Lords debates (via Lord Addington).

2000

- Speaker at the International Dyslexia Association Conference, Washington.
- Project for the Greater Manchester Probation Service on dyslexia as a factor in breached orders. Entailed materials production and training for probation officers and ETE workers.
- CPD has since been provided for several local probation services.
- Invited to join the DfES Skills for Life *Dyslexia Reference/Advisory Group*.

2001

- Training delivered to Manchester City College (which holds the majority of prison education contracts) including a whole day event for prison tutors.
- Presented at the Adult Dyslexia Organisation *Dyslexia and Offending* conference.

2002

- Work with College of Law on provisions for LPC and PgDL students with dyslexia, followed by staff training and a revision of disability policy.

2003

- Meeting with Home Office Minister Hilary Benn and the Offenders Learning and Skills Unit to bring forward concerns about dyslexia and the criminal justice system.

2004
